Annual Budget Brandon Booher, Treasurer

- Approved budget on September 6th <u>posted on website</u>
- Increase registration fees from \$1,200 to \$1,250
- Increase corporate sponsorship goal from \$10,000 to \$12,500
- Invest in new equipment:
 - New ergs (\$7,300)
 - New oars (\$3,600)
 - New shell (\$30,000) pay with cash on hand instead of finance
- Increase coaching salaries

Dec 10th - 1st Installment \$ 375


Jan 10th - 2nd Installment \$ 300

- Administration Quickbooks, VASRA membership, boat registration, State Commission, Accountant, USPS, etc.
- Boat Storage We have 12 racks inside the boathouse at Sandy Run.
- Insurance Property, Liability, Catastrophic, Directors & Operators
- Equipment & Maintenance Launch boat motors, shoes for boats, riggers, seats, etc.
- Regatta Expenses Fees paid to row each boat in a Regatta. All regular season Regattas are covered by membership fee.
- Payroll We want to keep our coaches happy.



Annual Financial Review

- All books and accounts shall be reviewed at least once every year:
 - by a qualified independent auditor who may be a member of the RCBC
 - or by a committee composed of not less than three (3) individuals.
- The review shall be completed by the end of the calendar year.
- The results of this audit shall be made available to all standard and contributing memberships.

Accumulate 10 Volunteer Points

Raise \$200 In Fundraising

Example Volunteer Opportunities:

- Carpool Driver 0.5 points (per trip)

Corporate Sponsorships Kate Mattice

- Good for the team: reduces overall team fundraising requirements.
